Description of content: Commission Implementing Regulation (EU) 2024/3168 authorizes for the first time in the European Union and for a period of 10 years a preparation of zinc-L-selenomethionine as a feed additive belonging to the additive category "nutritional additives" and in the functional group "compounds of trace elements", for all animal species. This authorization is based on the favourable conclusions of a scientific assessment of the dossier submitted by the applicant, conducted by the European Food Safety Authority (EFSA). The terms of the authorization are detailed in the Annex to the Act.
