Description: On 3 July 2025, the Environmental Protection Agency (EPA) promulgated amendments to compliance dates in the National Emission Standards for Hazardous Air Pollutants for Integrated Iron and Steel Manufacturing Facilities (Integrated Iron and Steel Manufacturing) through an [interim final rule](#) (notified as [G/TBT/N/USA/2026/Add.4](#)). The EPA received requests to schedule a public hearing. Given the public interest and to further public participation, the EPA is granting these requests and will hold the public hearing via virtual platform. The public hearing for Integrated Iron and Steel Manufacturing will be held on 3 September 2025. In addition, the EPA is extending the deadline for written comments listed in the interim final rule to 2 October 2025. The EPA will consider submitted comments and address them as appropriate.

Comments in response to the 3 July 2025, interim final rule for Integrated Iron and Steel Manufacturing must be received by 2 October 2025.
