6. Description of content: The draft Resolution provides for the approval of Technical Regulation on ecodesign requirements for the placing on the market and putting into service of servers and online data storage products.

The Technical Regulation addresses all environmental impacts throughout the life cycle of servers and data storage products – from concept, design, production and use to disposal. Its implementation is intended to improve the energy efficiency and environmental performance of these products and to enable the gradual phase-out of those with the most significant adverse effects on the environment.

It is established that the placing on the market and the putting into service of servers and data storage products placed on the market before the date of entry into force of this Resolution may not be prohibited or restricted on the grounds of non-compliance of such products with the requirements of the Technical Regulation on ecodesign requirements for servers and data storage products approved by this Resolution.

The draft Resolution also amends the Technical Regulation on Ecodesign Requirements for Computers and Computer Servers, approved by the Resolution of the Cabinet of Ministers of Ukraine No. 737 of 14 August 2019 and the List of Product Types Subject to State Market Surveillance by State Market Srveillance Authorities, approved by the Resolution of the Cabinet of Ministers of Ukraine No. 1069 of 28 December 2016.

7. Objective and rationale, including the nature of urgent problems where applicable: Protection of the environment; Quality requirements; Harmonization

Proposed date of entry into force: This Resolution shall enter into force six months after the termination or cancellation of martial law in Ukraine, but not earlier than the date of its publication.

The amendments set out in paragraph 4 of this Resolution, concerning the Technical Regulation on Eco-design Requirements for Computers and Computer Servers, shall take effect twelve months after the Resolution comes into force.
